Subject:-Issuance of Letter of Permission (LoP) to the Chairman, Hyderabad Karnataka Development Education Trust, Near Sindenkera Cross, Veerabhadragiri, Humnabad-585330, Dist. Bidar, Karnataka, on seeking permission of the Medical Assessment and Rating Board for Indian system of Medicine, National Commission for Indian System of Medicine to establish a new Ayurvedic Medical College in the name Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre, Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 80 seats (instead of 100 seats) in UG (BAMS) course under section 29 of NCISM Act, 2020, for the academic session 2023-24.-reg.

#### Sir/Madam,

With reference to the subject mentioned above, I am directed to inform you that in pursuance of the provision of National commission for Indian System of Medicine Act, 2020, the Indian Medicine Central Council Act, 1970 (48 of 1970) has been repealed with effect from the 11th day of June, 2021. With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by subsection (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine ACT, 2020, Medical standards, requirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM ACT 2020 shall not be applicable.

- 1. I am to refer to your application vide ref no. HKDET/BPMAMC/ADM/APP-1/2022 dated nil of the the Chairman, Hyderabad Karnataka Development Education Trust, Near Sindenkera Cross, Veerabhadragiri, Humnabad- 585330, Dist. Bidar, Karnataka on seeking permission of Medical Assessment and Rating Board for Indian System of Medicine, National Commission for Indian System of Medicine to establish a new Ayurveda Medical College in the name of Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre, Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24, and to verify the available facilities of teaching, non-teaching, hospital staff and other facilities available, your college was visited for issuance of Letter of Intent (LoI) on 25.11.2023 & 26.11.2023 through hybrid mode by the visitation team of Medical Assessment and Rating Board (NCISM) and Letter of Intent (LoI) was issued to your college vide letter of even no. dated 27.11.2023, to establish a new Ayurvedic Medical college in the name of Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre, Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24.
- 2. Further, the Medical Assessment and Rating Board for Indian System of Medicine (NCISM) has carried out another inspection of the college on 28.11.2023 and 29.11.2023 through hybrid mode to assess the available facilities of teaching, non-teaching, hospital staff, practical training and other infrastructure facilities available for issuance of Letter of Permission (LoP) to establish a new Ayurvedic Medical college in the name of Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre,

Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24.

- 3. Thereafter, the assessment report and all other related documents were assessed in terms of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, the "Indian Medicine Central Council (Requirements of Minimum Standard for under-graduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant regulations there under and it was observed that the college is not fulfilling the basic eligibility criteria for establishing a new Ayurvedic Medical College with 100 seats in UG (BAMS) course under section 29 of NCISM Act, 2020, from the academic session 2023-24 due to the deficiency of one Professor in the department of Kriya Sharir & one Reader each in the departments of Ayurveda Samhita Siddhanta and Rachana Sharir.
  - a) Dr Sunil Patki (AYRS00310) On verification in OTMS, it was observed that the teacher is not linked to the institute as the application for appointment is not submitted in the OTMS. On verification of Annexure, it was observed that the teacher has submitted affidavit as Associate Professor in the department of Rachana Sharir and was present at the time of visitation. However, the teacher is already present in the visitation of (AYU0050) A.V. Samiti's Ayurveda Mahavidyalaya, Vidya nagar, Bagalkot Road, Dist. & Tal Bijapur-586109, Karnataka for the academic session 2023-24. Hence, the faculty may not be considered.
  - b) Dr Shaikh Abdul Saleem (AYKC2743) On verification in OTMS, it was observed that the application for appointment is in process and now pending with the teacher. On verification of Annexure, it was observed that the teacher has submitted affidavit as Professor in the department of Kriya Sharir and was present at the time of visitation. However, the teacher is already present in the visitation of (AYU0235) Sri Sai Ram Ayurveda Medical College & Research Centre, Sai Leo Nagar, Poonthandalam, Sriperumbudur, Taluk Kanchipuram, Chennai-600044, Tamil Nadu for the academic session 2023-24. Hence, the faculty may not be considered.
  - c) There is deficiency of one Reader in the department of Kriya Sharir.
- 4. However, the President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), decided to grant Letter of Permission to establish a new Ayurvedic Medical College along with a warning as per the approved Seat Reduction Policy in accordance of Section 28 (1) (f) of NCISM Act, subject to ratification in the ensuing Board Meeting of the Medical Assessment and Rating Board for Indian System of Medicine (NCISM).
- 5. As per the approved Seat Reduction Policy in accordance of Section 28 (1) (f) of NCISM Act 2020:
  - a. "For deficiency of every one teacher, seat reduction in the intake capacity shall be considered by reducing the intake strength by 10 % of total intake capacity."

Accordingly, as per Schedule–V Note (iii) of MSR 2016 the deficiency of teacher for up to hundred intake capacity shall not exceed more than **ten percent** of total requirement. As per the assessment report, the college is having only 7 total eligible teaching faculty against the required number of 10.

There is deficiency of **02 teachers** for issuance of **Letter of Permission (LoP) to establish a new Ayurveda Medical College with 100 seats from the academic session 2023-24** as per Schedule-V Note (iii) of MSR 2016. Therefore, in accordance of seat reduction policy 2023-2024, for deficiency of every one teacher, seat reduction in the intake capacity shall be considered by reducing the intake strength by 10% of total intake capacity.

Hence, after applying the Seat Reduction Policy in accordance of Section 28 (1) (f) of NCISM Act 2020, the college is fulfilling the basic eligibility criteria for issuance of Letter of Permission (LoP) to establish a new Ayurvedic Medical College in the name Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre, Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 80 seats (instead of proposed 100 seats) in UG (BAMS) course under section 29 of NCISM Act, 2020, for the academic session 2023-24.

6. Further, in accordance of the regulation 6 (1) (i) (ii), of "Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019, a letter was sent to the college to furnish fixed security deposit vide letter of even no. dated 30.11.2023 worth Rupees Two crore, for establishing a new Ayurvedic Medical College with 80 seats (instead of 100 seats) in UG (BAMS) Course, in favor of National Commission fund for Indian System of Medicine. In response of the same, your college has furnished the fixed security deposit in favor of the National Commission Fund for Indian system of Medicine through RTGS/NEFT/UTR. No. PKGBH23335835342 dated 01.12.2023 of rupees Two crore transferred by Karnataka

Gramin Bank, Karnataka (for a period of five years) and informed by the same vide an email, dated 01.12.2023.

7. Therefore, Letter of Permission is issued to the Chairman, Hyderabad Karnataka Development Education Trust, Near Sindenkera Cross, Veerabhadragiri, Humnabad- 585330, Dist. Bidar, Karnataka, to establish a new Ayurvedic Medical College in the name of Basavaraj Patil Memorial Ayurvedic Medical Hospital & Research Centre, Near Sindenkera Cross, NH 65, Veerabhadragiri, Humnabad, Basava Kalyan, Bidar-560073, Karnataka (Inst ID AYU0844) with 80 seats (instead of 100 seats) in UG (BAMS) course under section 29 of NCISM Act, 2020, for the academic session 2023-24 and relevant regulations thereunder, with a warning to fulfil the following:-

#### A. Requirements: -

- I. Herbal garden should be maintained as per MSR 2016.
- II. The OPD and IPD records should be maintained as per standards.

## B. Conditions: -

- I. The college shall submit an undertaking in the form of affidavit duly notarized within one month explaining the details of providing EPF and ESI facilities to the teaching, non-teaching staff of the Colleges/Hospitals and regularly paying the same as per the provisions of Employees' Provident Funds and Miscellaneous Provisions Act, 1952 & ESI Act, 1948 and relevant Rules and Regulations.
- II. It is further informed that minimum 15% of undergraduate seats of the **permitted intake capacity of 80 seats (instead of 100 seats)** shall be treated as All India Quota. The counseling for seats under all India Quota shall be conducted by respective counseling authority as designated by Central Government for A.Y. 2023-24 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counseling Authority of that State/UT. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government/NCISM for all India quota or the students admitted thereunder.
- III. It is also informed that determination of fee and all other charges in respect of 50% of seats in private Medical Institutions and deemed to be University should be as per the guidelines issued by NCISM vide ref no. BUSS/Fee/ASU/2022-23 dated 16.09.2022. Fees of the remaining 50% of seats are to be fixed as per the guidelines of Fee Fixation/Regulatory Committee (FRC) of respective State/UT/Deemed to be University.
- 8. Admissions made in violation of the above conditions will be treated as invalid and action will be initiated under NCISM Act & Regulations thereunder.
- 9. Further, as per Sub-section (7) of Section 29 of NCISM Act, 2020, The Medical Assessment and Rating Board for Indian System of Medicine may conduct evaluation and assessment of any University or medical institution at any time, either directly or through any other expert, having integrity and experience in medical profession, without any prior notice and assess and evaluate the performance, standards and benchmarks of such University or medical institution and if the college is found to be not maintaining the Minimum Essential standards as specified in the concerned Acts & Regulations then in accordance of Section 28 (1) (f) of NCISM Act, 2020 the issued permission of the college shall deemed to be withdrawn and denial of permission shall be issued by MARBISM for stoppage of admission for that particular academic year or the subsequent year.
- Discrepancies, if any, may be immediately brought to the notice of Medical Assessment and Rating Board for Indian System of Medicine, NCISM.
- 11. The following requirements should be fulfilled by the college by 31st December, 2023 and send a compliance report to get permission for the session 2024-25 as per applied intake capacity: -
  - All the requirements of the enforced regulations namely "the Establishment of New Medical College, Opening of New or Higher Course of Study or Training and Increase of Admission Capacity by a Medical College Regulations, 2019
  - ii) All the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
  - iii) All the requirements of the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2016 (for Ayurveda);
  - iv) All the requirements under the provisions of the NCISM Act, 2020 and relevant Regulations made thereunder should be fulfilled in toto.
  - v) All the requirements as mentioned above in **point no. 7. A**.
- 12. The college administration will ensure that sufficient qualified teachers and non-teaching staff in the college and requisite staff in the hospital, as per the NCISM ACT and relevant regulation thereunder, are in position

before the admission of the first batch of students in the 1<sup>st</sup> professional of BAMS is made, under intimation to the Medical Assessment and Rating Board, NCISM.

- 13. The college has to develop the requisite infrastructure for I, II and III professionals well in time as per the norms which will be verified by the medical assessment and rating board and accordingly the permission for taking admissions in subsequent academic session will be considered.
- 14. The college administration may take up the matter for recognition of the qualification under section 35 of the NCISM Act, 2020 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
- 15. The fulfillment of the condition given above may be made within the time period specified and compliance report should be submitted by the college to Medical Assessment and Rating Board for Indian system of medicine. The Medical Assessment and Rating Board for Indian System of Medicine will verify that the conditions have been fulfilled for considering the permission matter for the academic session 2024-25.
